If at any time Justice For Abused Animals Inc. - determines that the foster agreement needs to be revoked, we reserve the right to reclaim the animal(s) for any reason. If the foster family decides to cancel the agreement, we ask that the foster family give 72 hours' notice so that another foster home can be arranged.

_____ The foster family provides all food, bowls, bedding and care for the foster animal. The foster family also agrees to administer and medications, de-worm and/or flea prevention as necessary/prescribed.

_____ The Justice For Abused Animals Inc. - JFAA will be responsible for payment of vet bills incurred for each animal.

All veterinary appointments must be made by a representative. Vet visits not scheduled/approved by a member will

not be covered unless it is an emergency and you cannot get in contact with a Justice For Abused Animals Inc.-JFAA & member

_____ If the foster family decides they want to adopt the animal(s) they are fostering, they will still be required to complete an adoption application and pay the adoption fee. Fosters will be given priority in adopting, except if the animal has an approved home already waiting.

_____ When bringing foster animals to adoption events, we asks that the animal be clean and free of foul odors. Brushing or bathing may be necessary prior to any event. If bringing a litter box, please make sure it is fresh and clean.

_____ Unless otherwise authorized to do so by Justice For Abused Animals Inc.- JFAA., we ask that fosters not undertake to represent us to the public in any manner or engage in any activities on behalf of Justice For Abused Animals Inc.-JFAA at any time. Please do not hesitate to contact Justice For Abused Animals Inc. JFAA representative when you need advice or assistance.

I _____, am requesting to foster a (n) animal(s) with Justice For Abused Animals Inc.-JFAA . I agree to read and follow the rules and guidelines of the organization listed above. I agree to not hold any director, volunteer, board member, or any individual personally or otherwise responsible in the event that I sustain personal, financial, emotional, or property loss/damage while serving the organization. I understand neither Justice For Abused Animals nor any adoption site they may attend (including but not limited to Pets mart) is responsible for any illness or injury caused by any animals that I come into contact with during my time as a foster parent. I agree to hold harmless any individual or organization should I become sick or injured from animals as a result of me fostering. I agree to follow the supervision of all persons involved in volunteer management. I understand that as a foster parent I am an important representative of Justice For Abused Animals Inc. - JFAA and must do my best to represent the organization in a manner that is consistent with its articles, by-laws, guidelines, and/or philosophies. Furthermore, the undersigned, in consideration of being permitted to participate as a foster, does hereby agree to hold Justice For Abused Animals Inc.,JFAA, its agents and employees free and harmless from claims of any person, including but not limited to the undersigned, for personal injury or property damage caused by the animal on rescues property or at shelter events.

I understand that because I will be in contact with animals, it is important to discuss being vaccinated against tetanus with my physician. I should also address rabies and possible allergic reactions with my physician I release Justice For Abused Animals Inc.-JFAA from all responsibility for any situation that may occur because I did not pursue this matter further, and I understand that whatever decision I make is at my own risk.

I acknowledge and understand that as a Justice For Abused Animals Inc.-JFAA foster, I am not covered by any insurance policy for damages or injuries sustained during volunteering activities.
